- ⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of CAD 510 (DKK 2,640) shall be charged for the first passport and CAD 218 (DKK 1,130) or CAD 345 (DKK 1,782) for subsequent passports.
